Duval County Fair General Rules

The following are the general rules that govern the Duval County Fair Auction Association. All general rules will apply to all division with specific rules reserved for particular divisions and/or classifications.

- 1. FAIR DATE: March 2nd 3rd, 2018
- 2. EXHIBITOR QUALIFICATIONS: Fair participants as exhibitors must belong to one or more of the following organizations in Duval County, but can only exhibit in one county.
 - High School Metal Fabrication
- Family & Consumer Sciences (FCCLA, Family Career Community Leaders of America)
 - High School Vocational Agriculture (FFA)
 - Jr. FFA
 - High School Industrial Arts
 - High School Building Trades
 - High School Art Classes
 - High School Auto Mechanics
 - Photography
 - 4-H Clubs

(Participation from 4-H clubs is restricted to students that have not graduated from high school and who have met the registration deadline of Sept. $\mathbf{1}^{\mathrm{st}}$)

- 3. VALIDATION: Exhibitors must validate all livestock projects by the deadline designated by the San Diego Rotary Club Board of Directors. Late validations will NOT be accepted. The following validation dates will be strictly adhered:
- Second Saturday in October 10/14/2017 9:00 a.m. to 11:00 a.m.

Market Steers, Market Goats, Market Lambs and Breeding Animals (Bulls, Heifers, Billies and Nannies)

•First Saturday in December- 12/2/2017 9:00 a.m. to 11:00 a.m.

Market Swine

•First Saturday in February- 2/3/2018 9:00 a.m. to 11:00 a.m.

Market Rabbits, Market Poultry, Kiddie Show Animals: Calf, Goats, Lambs, Swine, Rabbits and Home Show Entries (Non-Livestock Entries)

- Limited Three (3) Market Animals.
- 4. CHECK-IN AND DISMISSAL: Entries must arrive on the Fairgrounds between 8:00 a.m. and 2:00 p.m. on the Friday of the Show. Everyone must check-in at the designated area. Livestock entries will not be allowed to leave the fairgrounds after 4:00 p.m. on Friday of the show. Entries will remain in place until 5:00 p.m. on Saturday of the show or until such time is designated by the San Diego Rotary Club Board of Directors. Anyone removing a project(s) without following proper checkout procedures will be subject to a \$100.00 fine and/or a 2-year suspension from the Duval County Fair at the discretion of the Rotary Club Board of Directors.
- 5. SIFT: Sifting judge will sift animals according to the existing rules using general sifting practices. All livestock entries will be presented to a qualified sift judge by exhibitor. Sifting will begin at 2:30 p.m. on Friday of the show. Livestock entries will be sifted in the following order: Steers, Lambs, Goats, and Swine. Rabbits and Poultry will be sifted separately beginning at 4:00 p.m.
- 6. SIFTED PROJECTS: Livestock entries will be subject to general sifting practices before being exhibited. The decision of the sifting judge will be final. Sifted entries will not be allowed to show or sale. Sifted projects must be removed from the fairgrounds by 9:00 P.M. on Friday of the show.
- 7. PROJECT HUSBANDRY: Exhibitors will be assigned pens or stall spaces by the San Diego Rotary Club. Exhibitors of livestock will be responsible for feeding, watering, and the comfort of the project throughout the duration of the show. Neatness and cleanliness of all holding areas and premises for the livestock will be the responsibility of the exhibitor. No tarps, covers, or canvases will be allowed in the livestock barn. No cleanup of pens during auction sale. Non-compliance to Rule # 7 will result in a \$50 monetary penalty to the exhibitor.

- 8. NON-LIVESTOCK EXHIBITS: Exhibitors on non-livestock entries will be responsible for the safekeeping of their projects. Organizations are encouraged to assign security for safekeeping of projects.
- 9. LATE PROJECTS: Livestock exhibitors will be responsible for immediate presentation of their project for sifting, judging and selling. Failure to present the project when called for **SHALL BE** grounds for disqualification or nonconsideration. There will be **NO** deviation from this rule.
- 10. UNMANAGEABLE PROJECTS: All cattle must be properly halter trained for showing. Cattle that cannot be controlled by the exhibitor may be disqualified. Exhibitors must show their own project unless advance permission is acquired for those exhibitors who may be physically disabled. All other exhibitors will not be allowed assistance by another individual during the showing of the project.
- 11. MISCONDUCT: Misconduct on the part of any person (exhibitor, parents, grandparents, etc.) not becoming to the spirit of fair play, or cruelty to any animal, shall be grounds for immediate ejection from the show and permanent suspension from the Duval County Fair.
- 12. DRUG TESTING: All livestock must meet State and Federal Animal Health Commission Regulations. No drug or foreign substance will be administered to any animal without the consent of the division superintendent. Due to Federal Regulations all projects shown at the Duval County Fair will be subject to FDA and USDA testing at slaughter plants. If the projects test positive, the exhibitor or producer of the animal will be held responsible for any violations. Funds will be withheld from any exhibitor by the San Diego Rotary Club for exhibitor and buyer re-sales on such violation. All livestock entries will be subject to drug testing at the discretion of the San Diego Rotary Club Board of Directors.
- 13. EXHIBITOR SUBSTITUTION: In case of conflicts in the schedule of the exhibitors due to school or 4-H sponsored activities, with advance permission from the San Diego Rotary Club Board of Directors, an exhibitor maybe permitted to have someone from the school organization or the 4-H Club that is being represented to present his/her project.
- 14. JUDGES: The San Diego Rotary Club Board of Directors will be responsible for acquiring qualified judges for livestock and non-livestock projects. Judges will in **NO WAY** be affiliated with the schools, clubs, or the individual exhibitors. School alumni cannot be used as judges. Livestock judges shall be rotated every two years.

- 15. SHOW DIVISIONS: Divisions for exhibiting can be added or deleted for any given fair year. A majority vote of the San Diego Board of Directors will determine what divisions will be part of each fair.
- 16. DISCLAIMER: The San Diego Rotary Club will assume no responsibility for *lost* or *stolen* projects. Every effort is made to provide a safe environment for our event, however the safety and comfort is *solely* the responsibility of the exhibitor.
- 17.** STUDENT ELIGIBILITY: The Duval County Fair abides by all legislative mandates on student eligibility as prescribed by House Bill 72 and Senate Bill 1. No ineligible student will be allowed to show or sell their animal or substitute another exhibitor to do so. The San Diego Rotary Club will require all exhibitors to present a current report card for the designated grading period before check in.
- 18. VALIDATION COMMITTEE: All animal projects must be owned, placed on feed, and cared for by exhibitor for the duration of the feeding period. A validation committee appointed by the San Diego Rotary Club reserves the right to conduct unannounced project visits throughout the feeding period.
- 19. SHOW RING DRESS CODE: No tee shirts, sweatshirts, tank tops, head wear (hats or caps), sunglasses or sandals are to be worn in the show ring or auction ring. Suggested dress wear includes: Jeans, dress shirt or comparable clothing. Club jackets may be worn. Shirts must be tucked in and person must appear neatly dressed. No other decoration allowed.
- 20. HAIR CLIPPING: No hair clipping with electric clippers of all animals will be allowed on the fairgrounds. All animals must be properly clipped prior to arrival on the fairgrounds and presentation to the sift judge.
- 21. BUCKLES: Buckles will be awarded to the following: Grand Champion, Reserve Champion and Showmanship Market Steer, Market Swine, Market Rabbits, Market Poultry, Market Goats, and Market Lambs. Judge will choose two (2) exhibitors in each weight/age class to return to the ring to compete for showmanship in that division.
- 22. PLAQUES: Plaques will be awarded to the all 1st and 2nd place Class winners in Light, Medium and Heavy of Market Steers, Swine, Goats and Lambs. Plaques will be awarded for all Breeding Classes.
- 23. ENTRY FEES:

Market Steers-\$50.00

Non-Livestock (Wood/Metal) -\$25.00

Market Lambs-\$40.00

Non-Livestock (Home Show) - \$10.00

Market Poultry-\$40.00

Market Goats-\$40.00

Market Rabbits-\$40.00

Market Swine-\$40.00

Breeding Livestock-\$50.00

Kiddie Animals-\$30.00

Livestock Division Rules

- 1. All general and special rules apply to each class as well as rules unique to that class.
- 2. Only validated show entries will be allowed to sell in the Duval County Fair Auction.
- 3. Fifteen (15) animals will be sold from each market division in the auction, excluding Market Steers which will sell ten (10). Kiddie Show Grand and Reserve Champions will sell after the Market Grand and Reserve Champions sell. Alternate positions will be selected from each division to sell if an exhibitor withdraws from the sale order. Grand Champion and Reserve Champion Non-Livestock (Foods & Nutrition, Clothing & Textiles, Arts & Crafts, Art & Photography, Welding and Metal, and Carpentry & Woods) entries must sell at auction.
- 4. Entries in this division may be purebred, grade or crossbred. No breed distinction.
- 5. Once the sale order has been printed, NO ANIMAL CAN BE WITHDRAWN FROM THE AUCTION SALE. THE ANIMAL MUST SELL TO THE HIGHEST BIDDER.
- 6. An Exhibitor may only sell one market animal at the fair unless the exhibitor has multiple Grand or Reserve winners. In that case, all of the exhibitor's animals placing Grand or Reserve must be sold.
- 7. All animals will be judged as to grade.
- 8. Each Exhibitor is responsible for the delivery of his/her animal to the buyer. This means that the Exhibitor shall remain with his/her project until the Auction is over and must deliver the animal as instructed by the buyer. If the animal is designated for resale, the animal is to be delivered by the Exhibitor to the designated area for resale animals immediately exiting the show ring. No resale

animal will be allowed back into the show barn after the sale. Penalties will be strictly enforced causing the exhibitor to be disqualified from future participation in the Duval County Fair. All monies and awards will be forfeited.

- 9. All animals must be removed from the Fairgrounds by 10:00 a.m. on Sunday of the show or will automatically become property of the San Diego Rotary Club.
- 10. All sale entries will be sold by the head in order of placing starting with the Grand Champion, Reserve Champion, third place, fourth place, fifth place, sixth place, and etc. for Market Steers, Market Swine, Market Lambs, Market Poultry, Market Rabbits and Market Goats.
- 11. The price received by all participants in one class is set by the Grand Champion of that particular class. The Reserve Grand Champion can bring no more than \$1.00 less than the Grand Champion. The rest of the placings can bring no more than \$1.00 less than the Reserve Grand Champion.
- 12. There will be no resale of any item sold at the regular auction by exhibitor or buyer. Any resale item will automatically belong to the San Diego Rotary Club.
- 13. A commission of EIGHT percent (8%) will be retained on all auction sales and add-ons by the San Diego Rotary Club to cover expenses.
- 14. The San Diego Rotary Club will invoice auction buyers within 15 days of the sale. Payment of purchased projects is due within 30 days of the invoice date.
- 15. Exhibitors will receive payment of all sale items at one time as soon as ALL monies are received from the buyers; no money due to participate will be disbursed until all money is collected.
- 16. Buyers and Exhibitors alike retain all sales slips issued to them. Lack of such receipt will void any and all claims of error.
- 17. The San Diego Rotary Club will keep all projects that the club buys at the Auction.
- 18. Exhibitors are prohibited from soliciting for add-ons on the day of the Fair/Auction.
- 19. Exhibitors who put their entry through the Auction will not get their entry back. If the buyer decides not to keep the animal he/she bought, the buyer will receive the resale price for the particular animal which he/she bought. The Buyer

may donate that amount to the Exhibitor or an organization of his/her choice by requesting that animal be put in their name when it goes to the auction.

- 20. Any entry that has sold at auction, at another show, will not be able to show or sell at the San Diego Duval County Fair.
- 21. No spectators will be allowed in holding area, only exhibitors along with ONE (1) designated assistant or helper.
- 22. Any solicitation or add-on letters mailed out by exhibitors or participates must include the remittent address of the San Diego Rotary Club; San Diego Rotary Club, P.O. Box 427, San Diego, TX 78384. All add-on money regardless of amount must be made payable to San Diego Rotary Club. Any project being validated to show at the Duval County Fair must abide by the San Diego Rotary Club General Fair Rules. Non-compliance on add-on money rule will forfeit any proceeds that exhibitor is due and participation in any future Duval County Fair.
- 23. Judge will place Market Steers, Market Swine, Market Goats and Market Lambs division as usual. Each like winner (1st, 2nd, 3rd, and so on) will be sold with like winners. These animals will no longer return to the ring for selection of sale order. Please note Market Rabbits and Market Poultry have no weight classes—this will not affect them.
- 24. Showmanship in Market Steers, Swine, Goats, Lambs and Breeding Beef Bulls, Heifers, Nannies and Billies will be selected by judge who will pick (2) two exhibitors from each weight or age class to compete for Showmanship for that division.

Livestock Classifications

Market Steers Division

1. Show Weight

Minimum: 900 lbs. Maximum: 1450 lbs.

- 2. Steers must be dehorned prior to validation.
- All ear tags except TX validation tags must be removed prior to steer validation. Duval / Freer validation numbers will be used for animal identification. No tag alterations-any changes to size, shape, form or color will void the entry.
- 4. Steers must be sheared before check-in no longer than ¼ inch.
- 5. Steers will be broken into (3) weight classes.

Market Swine Division

1. Show Weight

Minimum: 220 lbs. Maximum: 285 lbs.

- 2. All market swine (barrows and gilts) will be broken into (3) weight classes.
- 3. Swine need not to be slick shorn.

Market Lamb Division

1. Show Weight

Minimum: 90 lbs. Maximum: 160 lbs.

- Market lambs must be slick sheared prior to check-in. Wool length will be checked when presented for sift.
- 2. All market lambs (wethers and ewes) will be broken into 3 weight classes.

Market Goat Division

1. Show Weight

Minimum: 70 lbs. Maximum: 120 lbs.

- 2. Horns must be tipped prior to check-in.
- No pronged (barbed) neck collars or pinch collars allowed at sifting or show time.
- Shearing / Clipping must be done prior to check in. Market goats will be checked for hair length when presented for sift.
- 5. All market goats (wethers and ewes) will be broken into (3) weight classes.

Market Rabbit (Fryers) Division

1. Show Weight

Minimum: 3 lbs.

Maximum: 5 lbs. 5 oz.

- 2. Up to 5 rabbits can be validated as a pen.
- 3. 1 pen = 1 entry
- 4. Exhibitors may not mix pens (rabbits) your pen of 3 rabbits must come from the same official validated pen.
- 5. All rabbits must be owned by the exhibitor, on feed and under the care of the exhibitor prior to show.

6. Any rabbit showing any obvious signs of deformity, disease, external parasites, buck teeth or missing toes will be sifted.

Market Poultry (Broiler) Division

1. Show Weight

Minimum: 10 lbs. per pen

- 2. Pen will consist of (3) broilers of the same or mixed sex.
- 3. All poultry will be ordered and purchased through the Duval County Extension Office.
- 4. All boilers will be wing-tagged prior to issuance to exhibitors.
- 5. Exhibitors may enter up to 2 pens of (3) broilers.
- All exhibitors may bring 1 extra broiler per pen as a substitution for sifted animal.
- Exhibitors are responsible for the safety and care of their projects. The exhibitors must provide their own feed, water and containers.
- 8. A qualified sifting judge will be appointed by Rotary and all birds will be examined to determine live market value.
- Entries showing symptoms of sickness, disease or external parasites will be sifted or by official judge if discovered during the show.
- 10. Birds with breast blisters or bruising to the degree that is determined objectionable may be sifted.

Kiddie Division

- Safety Reasons: Age of exhibitors must be at least 4-8 years old, be a
 permanent resident or student within the Duval County School District and
 not yet eligible for 4-H membership. (8-year-old 3rd grader is not eligible for
 Kiddie Show) age is as of Sept.1,2017.
- 2. Kiddie livestock entries are limited to Swine, Goat, Lamb, Rabbit and Beef Calf must not be older than 90 days at show time.

Kiddie Swine - 120 pounds Maximum

Kiddie Goat - 60 pounds Maximum

Kiddie Lamb- 60 pounds Maximum

Kiddie Beef Calf - 300 pounds Maximum

Kiddie Rabbit- 5 pounds 5 oz. Maximum

3. All horned animals must be tipped or dehorned.

Junior Open Breeding Livestock Division

- 1. Breeding animals will be limited to Breeding Bulls, Heifers, Billies and Nannies.
- 2. Exhibitors may exhibit as many entries as they desire.
- 3. Breeding Animals will be divided Junior (Under 12 Months) and Senior (13 Months to 24 Months).
- 4. Registered animals need not be tagged. Identification will be based on fire brand or tattoo as per registration papers.
- 5. Once an animal has won Grand Champion, that animal is no longer eligible to participate in future Duval County Fairs.

NON-LIVESTOCK ENTRIES RULES AND REGULATION

Up for Approved January 2014

GENERAL RULES FOR ALL DIVISIONS

PLEASE READ CAREFULLY

ALL FEES need to be cleared by day of validation.

All Exhibitors must be passing all classes - (No Pass No Play) to Auction.

There will be a total of Eight (8) Grand Champions and Eight (8) Reserve Champions.

- 1. All general rules of the Duval County Fair Auction will apply.
- 2. The entries will be grouped according to age as follows:

Group 1

Sub-youth (age as of Sept. 1) 8 -10 years

(8 years or 3rd grade)

Group 2

Youth (age as of Sept. 1)

(11-13 years)

Group 3

Young Adults (age as of Sept. 1)

(14-18 years)

- 1. All articles must be the completed work of the exhibitor and completed since the last fair. All articles must be undamaged and clean. Unfinished articles will not be accepted. The Superintendent of each department has the authority to reject unworthy exhibits or items not packaged according to DIVISION RULES or to reclassify any article. Any items in Clothing, Textiles, and Crafts must be in separate disposable plastic bags. Food items must be in secured covered bags. Food requiring refrigeration will not be accepted.
- 2. Participants may enter as many entries in any given Division but, only on (1) per class; Example-Division Cake: Class: Angle Food
- 3. All articles must be validated (first Saturday in February) to be eligible for judging. All entry blanks must be completed in detail and returned for each items to be entered. Entry blanks will be available from leaders and department superintendents. No late entries will be accepted. Entry fees are due at the time of validations.
- 4. All Non Livestock (Non-Food) entries will be checked in on Thursday from 5pm 8pm. NO late entries will be accepted.
- 5. All Food entries in the Non-Livestock Division are to be entered with the Department Superintendent on Friday, between 8:30am and 9:30am. No late entries will be accepted.
- 6. Entries will be judged and given ribbons according to scores received. Ribbons are awarded on the basis of: Blue 90 -100; Red 80 89; White 70 79. A blue ribbon is required for Division Champion.

- 7. All entries receiving ribbons will remain on display until 4:00pm on Saturday.
- 8. A Sweepstake Rosette and Plaque will be awarded to the individual with the greatest number of points in each of the Sub-Youth, Young Adult age groups. Points will be tabulated form their class ribbons and Division Champion. Class ribbons will count for 5 points and division champions will count 10 points. In case of a tie, the individual with the most total ribbons will be the winner. The Sweepstake Awards will be presented at the Duval County Fair Auction on Saturday Night.
- 9. All items will be pickup by 4:00pm on Saturday. Projects not picked will be disposed.
- 10. All items must be able to hold together during transportation and judging. If an item is received damaged or falls apart, the item will be judged "as is"
- 11. All judge's decisions will be final.
- 12. Judging will be from 10:30 am to 4:00 pm on Friday.
- 13. Public viewing of projects will be from 4:00pm Friday to 2:45pm on Saturday.
- 14. All exhibitors are responsible for the safety of their entries. The San Diego Rotary Club will do the upmost to insure safety of all entries.
- 15. No Sponsors or Club Managers will be allowed in Judging Areas during the judging of projects.

CRAFTS DEPARTMENT

Superintendent-Rotarian

- 1. All General Rules of the Duval County Fair Auction will apply.
- 2. A record book containing
- 3. There will be no deductions for kits; however, all entries that are totally original can earn up to 10 extra points.

- 4. All jewelry shall be attached to a note card or tag board and in a plastic bag ready for display. Place 3×5 index card on them.
- 5. All items that must be hung must have a loop on a hanger attached so that it may be displayed, or matted with a cardboard backing.
- 6. All entries are eligible for sale at the county fair by Private Treaty, between child and buyer, where money is exchange immediately and which has nothing to do with The Rotary and its purchasing rules.

Explain in detail any techniques or variation that was used, plus any information that would be helpful to the judges. 5 points will be deducted if the 3 x 5 card is not attached.
- 3. Pictures may be framed, ready to be hung with wire or matted with a cardboard backing.

- 1. All general rules of the Duval County Fair Auction will apply to this department.
- 2. Attach a 3 x 5 index card stating type of camera, type of lens, filter, brand of film, use of flash, development, etc. Explain the location, season, and the effect desired. 5 points will be deducted if 3 x 5 index card is not attached with the needed information.
- 3. All photography pictures must be matted, not framed. If framed it will not be accepted, self-made mats are acceptable. 5 points will be deducted if in a frame.
- 4. All photography entries must have negative accompany photo, excluding instarnatic. Negatives must be in an envelope attached to the back of entry.
- 5. All entries are eligible for sale at the county fair by Private Treaty, between child and buyer, which money is exchange immediately and which has nothing to do with The Rotary and its purchasing rules.

Negatives $01 \cdot$ data device (Disc) must be in an envelope attached to the back of entry.

- 3. There will be no deductions for kits; however, all entries that are totally original can earn up to 10 extra points.
- 4. All items that must be hung must have a loop on a hanger attached so that it may be displayed.
- 5. Exhibitor must be available for interview regarding project.
- 6. All entries are eligible for sale at the county fair by Private Treaty, between child and buyer, where money is exchange immediately and which has nothing to do with The Rotary and its purchasing rules.

WELDING AND METAL DEPARTMENT

Superintendent - Rotarian

- 1. All genera I rules of the Duval County Fair Auction will apply.
- 2. All welding projects will be judged in one class.
- 3. All projects must be fabricated by the student/students entering he class.
- 4. Exhibited projects must be fully completed (welding, sanded, painted, and etc.)
- 5. All entries are eligible for sale at the county fair by Private Treaty, between exhibitor and buyer, where money is exchange immediately and which has nothing to do with The Rotary and its purchasing rules.
- 6. Exhibitors are required to turn in a record book documenting the construction of their project. The record book will be judged along with the project.
- 7. Exhibitors must be by his/her project during the judging. All exhibitors must be prepared to answer questions about their project at the Judge's discretion.

CARPENTRY AND WOODS DEPARTMENT

Superintendent - Rotarian

- 1. All entries will receive a ribbon based on individual effort.
- 2. Entries must be in place by designated time on day on judging.
- 3. Projects will be grouped with like, (i.e. gun cabinets, gun racks, etc.)
- 4. Projects must be done completely by student or students. Any student who received production by adult will be disqualified from competition by the judges.

- 5. All entries are eligible for sale at the county fair by Private Treaty, between exhibitor and buyer, where money is exchange immediately and which has nothing to do with The Rotary and its purchasing rules.
- 6. No paint is to be used to cover wood grain. Stains, varnishes, etc. are only finishes allowed.
- 7. Exhibitors are required to turn in a record book documenting the construction of their project. The record book will be judged along with the project.
- 8. Exhibitors must be by his/her project during the judging. All exhibitors must be prepared to answer questions about their project at the Judge's discretion.

BAKING AND CONFECTIONARY DEPARTMENT

Superintendent-Rotarian

- 1. All General Rules of the Duval County Fair Auction apply to this department.
- 2. No prepared mixes may be used as the main ingredients. The Snack Division is only for Group 1 ages 9 10 and Group 2 ages 11 13. Youth exhibits will be disqualified.
- 3. Cakes, Pies and Breads will be whole when entered. Cakes may be placed on a foil covered board and covered with clear plastic for judging. Cakes may also be placed in a disposable plastic cake carrier, a disposable aluminum pan, a sheet cake or a glass cake stand with glass cover. (Remember if the cake sells you won 't get your carriers back.) Creative cakes must be on a sturdy covered board and if multi tiered or elaborate do not need to be covered. These cakes will be judged on taste as well as appearance, just like all items in this department.
- 4. A batch of candy, cookies, cupcakes, muffins, rolls or tortillas etc. will be required for an exhibit. Baked exhibits or candy should be displayed in disposable pans or slipped into a zip-lock bag with a disposable plate or tray underneath. All items must be packaged to be accepted.
- 5. Entries must be accompanied by a record book. Not enclosing the recipe book will cause a 5point deduction.
